2016 MAINTENANCE FEES

By the time you receive this newsletter, you should have received a statement for the first half of the 2016 Maintenance Fees. They were mailed by *GREENACRE PROPERTIES, INC., our management company,* to all residents in early December. If you have not received your statement, or have any questions concerning your account, please call Robyn Lavanda at Greenacre Properties. Her number is 813-936-4127, or call the main number (813) 600-1100 and dial extension #127. You can also e-mail her at:

For the first time in (5) years dues have increased from \$213 to \$229 per half year, for homeowners and from \$160 to \$172 for condo owners. The first half were due on January 1st, 2016. You can pay the full year assessment of \$458 for homeowners and \$344 for condo owners. If you have not sent your payment for the first half, please do so now and allow 3-5 days for mailing and posting to your account. WLCA OFFICE WILL NO LONGER ACCEPT DUES PAYMENTS. Mail your dues to the address provided in the mailout.

If you will be unable to pay your dues by January 31, 2016, please contact the WLCA office immediately at 813-754-8999. We will make every effort to work with you on a payment plan in order to avoid collection and attorney fees.

LET'S "PAY IT FORWARD"

As we end 2015 and begin 2016, our Walden Lake Community has a lot to be thankful for and pleased with. This past year our association has undertaken and completed a multitude of physical improvements and upgrades of community assets. Many have been mentioned in past newsletters; however, we need to continue to work together as neighbors and residents to improve our neighborhoods and quality of life.

One idea, with the new year upon us, is to consider "Paying It Forward" with our efforts around our homes. As we maintain our properties, please consider just one action-that as we pressure wash our houses, roofs, sidewalks and driveways, please consider pressure washing your curb (drainage swale) and that of the neighbor on each side of you. With a concerted, collective effort we can improve the visual appearance of our neighborhood streets. The WLCA is undertaking the pressure washing of the median curbs/islands along Timberlane and Griffin and our entrances. This effort, combined with our upgraded landscaping program, will certainly enhance our physical appearance and reflect positively upon our community of neighborhoods.

Along the same vein, the WLCA Board of Directors in December adopted a 2016 budget with a slight increase in dues: HOAs went from \$213 to \$229 semi-annual and condos went from \$160 to \$172 semi-annual. You have already received your notice/coupon in the mail along with the 2 auto decals. This is the first increase in dues/assessments in 5 years, and compared to other community associations, ours are quite reasonable. The increase was driven primarily because of a recommendation from our Reserve consultant (funds for major capital improvements) identified that we needed to set more funds aside each year because of the age of our community's physical structure and need to replace/improve it, new security service and coupon mailing.

At the beginning of 2016 our efforts will be reflected in improved lake fountains, office building handicapped accessibility, guardhouse upgraded high definition camera system, major tree replacement, completion of the first pavilion in the Polo Field Sports Complex, along with the availability of two 4-square game pads, the soccer field outlined, the base-ball field completed and the benches on the berm and team benches installed. The complex will gradually come together in the next few years with a ¼ and ½ mile walking track, exercise stations, basketball court, etc.....for our resident's daytime usage. And, we are hopeful to convince the USPS to restore "our" Mail Drop Box at the entrance.

Next year the WLCA Board of Directors will be recognizing and encouraging **National Night Out- August 2, 2016**-an annual community building campaign that promotes the relationship between neighbors while bringing back a true sense of community. Check out their website.

And, finally in "Paying It Forward", please call the office with any issues of fallen or dangerous trees, broken/leaning signs, broken sprinkler systems, street lights out, etc. We need to work together in improving our community, neighborhoods and city.

2016 DECALS

Enclosed with your 2016 statement, were 2 new decals. If you did not receive any decals with your statement please call our office @ 813-754-8999. Only those residents who were current with their dues, as of December 31, 2015, received them.

Please remove the old decal (or any other old decal) currently on your vehicle and replace it with the new white **round** decal. They should be placed in the lower left corner of the driver's side, inside windshield. Please clean the windshield and then make sure that any air bubbles are removed. The new decals have a slight adhesive on them, so they will adhere better and not curl up. As of approximately January 15th, the Gatehouse attendants will stop vehicles that don't have the new decals.

If you need additional decals, they are \$15 for one and \$25 for each additional. Office hours are <u>8:30AM to 5:30PM</u>, Monday through Friday.

LANDSCAPING UPDATE

- In the process of replacing electrical lights for the entrances for each subdivision as needed, with more updated equipment.
- A program is being put together to pressure wash all gutters in the community. We would appreciate all Presidents from each sub-division to join in this effort.
- Our maintenance department will inspect and align all road signs, including all signs through-out the park and walking trails.
- Landscaping company will start cutting back the overgrown areas around the lake and walking trail.
- Bridges will be pressure washed to eliminate the green moldy build-up to prevent accidents.
- Will be meeting with the City to identify all trees that need to be trimmed or removed.
- Josh Hall & Ray Page, directors, will meet with the City Manager to see if we can get recycled water to our medians along Timberlane.
- Poinsettias and impatiens were planted at both entrances, and subdivisions.

- The landscape committee would like to thank Eddie Evans and CLC for their cooperation in helping to get some of these projects completed.

THE WALDEN LAKE COMMUNITY ASSOCIATION **Board of Directors Election**

March is the time of year the Association mails out the Notice of Annual Meeting and ballots for the election of Director to the Association Board.

There are nine Directors, each serving a three-year term, so every year three positions are open for election. There are no term limits, so Directors often serve multiple three-year terms, but are eligible to run for re-election every three years. After the annual homeowners meeting and election, the Board elects its officers for the following year. There are numerous committees that oversee the Association's business. These committees, such as Budget and Finance, Landscaping and Special Events meet as required and prepare reports and recommendations for the monthly Board of Directors meetings. A General Manager operates from the Association's business office at 3035 Griffin Blvd and conducts the daily business of the Association. Directors need to commit to regular attendance at the monthly meetings and have a willingness to serve on the committees. The monthly Board meetings are structured and are governed by Robert's Rules of Order. The Board meets the third Monday of each month at 7:00 pm unless otherwise specified.

In early February we will be mailing the letter of intent packet for the 2016 election. We encourage anyone interested in running for the Board of directors to respond during the specified time frame outlined in the mailing by completing the notice of Intent form and sending it in before the posted deadline.
