PRESIDENTS CORNER - SHARON PHILBIN

Greetings fellow WLCA residents:

2017-2018 continues to be a productive and busy year in Walden Lake. A Special thank you to our manager Tom Sholl and the entire staff, Bette Guarino, Marlene Merrin, Larry Truman, Kenny Hall and our Landscape Contractor CLC Landscape.

- Reminder, use of the park by people who do not have a WLCA decal is an ongoing problem. Signs are posted. We do have a towing policy and cars are tagged with a warning. There has been some towing of cars. Extra decals can be purchased at the WLCA office with proof of address.
- Update on golf course: the foreclosure by Today's Bank v.
 Visions Golf has been completed. As of this writing, Today's Bank is in ownership of the property and is still mowing the shuttered Golf courses.
- City officials have indicated that Timberlane resurfacing should begin in June. A full depth restoration and paving will be implemented and should be completed within 2-3 weeks.
- Walden Lake residents continue to donate a record amount of food to the food bank. The Food Bank thanks you.

- ◆ The sports complex is in full operation with baseball field, soccer goals, horseshoes, tetherball and foursquare. WLCA is planning on installing a pickle ball court.
- WLCA has approved the addition of a well to water the sports complex. The cost of city water versus a well will be a huge savings and the well would pay for itself in three months.
- It has come to our attention that people have been feeding wildlife on the lake trail. Residents should keep in mind that wild animals do live and travel through the wooded and nature areas of Walden Lake. As a reminder, please refrain from feeding, attracting or approaching any wild animals.
- Reminder, lock your cars as there have been several burglaries of unlocked cars as well as locked.
- If you have not done so, please consider registering at waldenlake.org. This site is for WLCA residents and provides a great deal of information. The site also allows staff to send out alerts to our residents.



UPDATED FISHING POLICY



The following is an excerpt from the new Fishing Policy adopted by the WLCA Board of Directors at the meeting of March 19, 2018. A full copy is visible on the WLCA website or you can come by the WLCA office for a copy.

- 1. Fishing is only permitted in (1)Walden Lake (the large lake adjacent to the Children's Park and Parking lot) and (2) from the Association owned property in the Association owned portion of the pond located opposite the Children's Park (the Association owned property is the portion of the pond to the North of Timberlane Drive. It does not include the back side of the pond). Fishing in all other Water Bodies is prohibited, except as permitted in No. 5 below.
- 2. Only Walden Lake Community Residents may fish in Walden Lake.
- 3. No person shall trespass on any lot or parcel to fish.
- 4. A resident whose property abuts a water body and any permitted guests of the resident may fish on Water Bodies other than Walden Lake but only from the resident's property and only within that portion of the water body that abuts the resident's property.
- 5. The Water Bodies may contain chemicals from water run-off. No one shall consume or ingest or allow another person or animal to consume or ingest anything caught within the Water Bodies.

DOG PARK

Hurricane Irma destroyed the much beloved oak tree at the Walden Lake Community Dog Park. As a result, the dog park lost its greatest source of shade for the dogs and their owners.

The Master Association has built a new 12 foot by 16 foot pavilion




with concrete slab flooring to provide shade to both sides of the dog park. The pavilion spans 12 feet across the fence line so large and small dog owners can congregate in the middle (a feature many have wanted for a long time). The pavilion also includes built-in benches and extra overhang on the roof to provide additional shade.

As you can imagine, this type of structure was expensive. The total cost of the new pavilion was \$10,000 and the WLCA Board has asked the members of the dog park to help offset the cost through personal contributions or contributions from the community at large. While individual members are stepping up and contributing money, we still need help from local businesses or individuals.

We have several tiers for contributions:

1. \$100 to \$250

a. Inscription brick installed at the Dog Park path.



2. \$251 to \$500

a. In addition to #1, your business will be advertised on a banner/sign to be placed at the entrance of the dog park for 1 year that states the names of the business that contributed.

3. Greater than \$500

a. In addition to #1 and 2, your business will be featured on a permanent plague on the pavil-

CITY OF PLANT CITY Police Department

Florida State law is very specific regarding the conditions in which a person may be cited and or arrested for trespass. A police officer does not have the legal authority to conduct

an investigatory stop or arrest for trespass unless the owner or his or her agent <u>first warned the potential trespasser</u> that he or she is no longer permitted to be present. *Gestewitz v. State*, 34 So. 3d 832, 834-35 (Fla. 4th DCA 2010); *S.N.J. v. State*, 17 So.3d 1258, 1259 (Fla. 2d DCA 2009) (stating that Florida's criminal trespass statute "requires that notice be given before a person can be guilty of trespassing on property," and that individuals "can be legally detained for trespassing only if they were first warned to leave the property"); *Rodriguez v. State*, 29 So. 3d 310, 312 (Fla. 2d DCA 2009).

Accordingly, absent a trespass agreement on file with the police department, the home owner must be present and a call placed to the police department for an individual to be "trespassed." Additionally, the individual who the home owner wishes to have trespassed must also still be on the home owners' property for the officer to issue the trespass warning. On the first occasion, the officer will issue/communicate a trespass warning. It is not until the second incident, that the individual can actually be charged with the crime of "trespass after warning," and at that juncture, the individual may be subject to citation/arrest.

Please note, for example, that if an individual is noticed not to trespass on the property located at 123 Main Street then two days later is found to on the property located at 456 Main Street, that is considered, by law, to be two separate incidents, each of which must be handled in accordance with established law. In short, you cannot combine trespass warnings. Each warning is for a specific address.

If a home owner is not routinely at their residence (Part-time resident, works full time, etc.), the home owner may elect to execute a trespass agreement with the Plant City Police Department. This agreement which is available at the police department, will allow a police officer, at your behest, to issue a warning to any individual who might be on the home owner's property.

Once the trespass agreement has been filed with the police department, the resident who has executed the trespass agreement must display, in a prominent location clearly visible from the street, the yellow warning sign, which indicates that the Plant City Police Department has the authority to trespass individuals from that specific location.

Solicitation would be handled as a trespass.



SOLICITING IN WALDEN LAKE

The city enforces trespassing and no solicitation issues with each private property owner. WLCA does not have authority to enforce, generally or specifically, the issue of solicitation.

The police have informed WLCA that if a resident posts a "No Solicitation" or "No Trespassing"

sign on their property then you can contact the police who can respond to the issues. Please be sure to conform any sign to your own subdivision's covenants.




