Fall is finally upon us! The Special Events committee has been working hard to bring the community an exciting Fall Festival on October 26th. As always security is a big concern of the board and our residents. The board has been looking at several security solutions and we are in the process of budgeting for these improvements. There will be significant upgrades to our security camera system at the gates and other locations throughout the community. Larry Britt, Chair of the Community Involvement & Safety Committee, has been in constant contact with our city officials to discuss the homeless and loitering issues that we are experiencing as well as other security concerns. I would like to thank Larry for his dedication and commitment to making Walden Lake a safer place to live. Please remember, if you see something that is out of place, please call the police.

On the development front, the Board of Directors Development and Enrichment Committee along with the Resident Advisory Council has completed the tabulation and analysis of the resident survey and the results are available on <u>waldenlake.org</u>. There have been a handful of meetings with the developer over the last few months. The minutes from these meetings are posted on our website, <u>waldenlake.org</u>. Talks continue to progress slowly but there are some key dates coming up that the WLCA Board and the Walden Lake Resident Advisory Council want all residents to be aware of.

11/07/2019: Resident Open Meeting

This is an opportunity for Walden Lake, LLC to present their plans to the community before they submit to the City for Plan Amendment and Zoning Changes. (Location will be announced)

11/21/2019: Follow Up Meeting with WLRAC and the WL Enrichment Committee

Final opportunity for Walden Lake, LLC to agree to any changes before they submit to the City for Plan Amendment and Zoning Changes.

12/02/2019: Developers deadline for plan submission

Walden Lake, LLC plans to submit to the city on or before this session deadline.

Three (3) Opportunities for residents to attend commission meetings

The changes requested by Walden Lake, LLC will require both a Plan Amendment change as well as a Zoning Change. In total this process will require (at least) three (3) commission type meetings where residents will have an opportunity to speak and express their support or concerns regarding the requested changes by Walden Lake, LLC.

All residents within 250 feet of any changes will automatically be notified. The WLCA will also be notified and those notifications will be published on the WLCA website.

It is expected the first (of the three (3) meetings) will be in February 2020.

The reduced fees are: \$25.00 – One Dog \$40.00 -Multiple Dogs \$10.00 - Key Deposit




