If you chose to proceed with changes prior to approval and the committee subsequently disapproves your request, you will be required to return your property to its previous condition at your expense or make changes to come into compliance.

If approval is granted, it is not to be construed to cover approval of any County or City Code Requirements. A building permit from the appropriate building department is needed on most property alterations and/or improvements, The ACC shall have no liability or obligation to determine whether such improvement, alteration and addition comply with any applicable law, rule, regulation, code or ordinance. All contractors must be licensed and insured.
