

The Board is in the process of reevaluating our collection process for past due HOA dues. It has come to our attention from residents of the community that the current policy is more aggressive than necessary. The Board has taken on the responsibility to restructure how we go about collecting past due HOA dues and I expect we will have the new policy in place soon.

It has also come to our attention that some residents have complained to the City that their trash has not been picked up. We have

come to find out the issue lies with residential landscape company's vehicles and trailers blocking the streets in the morning when the trash is collected. This prevents the City trash trucks from being able to get down the streets on collection days. Please make sure if you have a landscape maintenance company working in your yard that they provide adequate clearance in the street for the City's trash collection vehicles.

As always, our HOA meetings are held on the third Monday of every month.



Violation of the law can result in a fine, fees, and points on your driving records. If you see emergency lights, move over!




